Loss Based Assessments and Employer Assessment Factor

The Administration Fund, Subsequent Injury Fund and Supersedeas Fund are not included in the loss costs but are a separate charge to the insured. The attached exhibit presents detail of loss payments, budgeted expenditures and the resulting assessment levels. The indicated Employer Assessment Factor is 2.42%, a decrease of 0.47% from the current value of 2.89%.

The Small Business Advocate assessment as well as charges for the Merit Rating Plan and Certified Safety Committee Program are also included as part of the published loss costs. A factor of 1.48% is proposed as a load to loss costs for those items. The current factor is 1.45%.
