On behalf of the members of the Pennsylvania Compensation Rating Bureau, is a submission of a filing with proposed revisions to the Pennsylvania Statistical Plan Manual (Statistical Plan). These revisions are proposed to be effective April 1, 2018.

This filing proposes that **Statistical Code 1994** be approved to allow carriers to report a flat decrease for purposes of reporting the premium adjustments related to differences related to two recent PCRB filings.

Statistical Code 1994 is for use on policies written between April 1, 2018 and December 31, 2018, where the carrier has chosen to apply a flat decrease for purposes of reporting premium adjustments related to filing C-370 differences.

Code 1994 may also be used on policies written between January 1, 2019 and January 31, 2019 where the carrier has chosen to apply a flat decrease for purposes of reporting premium adjustments for Classification Code 994, Firefighter – Volunteer Fire Company, related to filing C-375.

Attached to this filing letter is a document which contains the proposed revisions that are displayed using standard "track changes" so you that you may track the newly inserted language. We have also included a final version without the "mark-up". Each section of the Statistical Plan is identified and if items remain unchanged, it is noted.
