**RE: PCR B Filing C-375, Informational Loss Cost Filing
Effective January 1, 2019**

Dear Commissioner Altman:

On behalf of the members of the Pennsylvania Compensation Rating Bureau (PCR B), we hereby submit Informational Filing C-375, which contains revised workers compensation loss costs only for Code 994, Volunteer Firemen, with an effective date of January 1, 2019. No other classification code rating values are changed in this informational filing.

Subsequent to the January 1, 2019 effective date for approved Filings C-372 (the Interim Loss Cost Filing) and C-373 (the Protz Adjustment Filing), the Schedule of Annual Loss Costs by population band for Code 994, in Exhibit 28 of Filing C-372 and Exhibit 5 of Filing C-373, were identified as having incorrect loss cost values. Revised Schedules of Annual Loss Costs for Code 994 for Filings C-372 and C-373 are included in this filing.

As noted in PCR B Circular No. 1714, the loss costs in Filing C-373 (the Protz Adjustment Filing), were to be used by carriers effective January 1, 2019. The loss costs in Filing C-372 (the Interim Loss Cost Filing) were simply informational and were not to be used effective January 1, 2019. The PCR B is submitting two sets of revised Code 994 loss costs to be consistent with the submission of those two filings.

The PCR B regrets any inconvenience caused by the error in the original filing submissions. Please direct all questions concerning this informational filing to Kenneth Creighton, Chief Actuary.
